- 5 A cancellation occurs due to a loss or other circumstance. Once a contract is canceled, our Administrator credits (or refunds) their portion of the customer refund to you.
- 6 We write you a check for the portion of the customer refund that you pay after receipt of the paperwork. We pay up to \$1000 of your portion for service contract refunds and up to \$600 of your portion for GAP, Key, Tire & Wheel and other F&I contracts.
